You are hereby noticed in good faith that you are in biblical dishonor of not exercising an opportunity to respond to the aforementioned ecclesiastical ***"Diligent notice of lawful excuse"*** of **the bondservant of Christ Paul-Joseph: of the Ricci family**, dated July 30, 2008, sent by registered mail and delivered/signed on or around August 1, 2008.

You were given the opportunity to make it clear that my evidence/facts and our agreement based upon *tacit consent* was or is in error. I offered you the opportunity to counterclaim and/or rebut, dispute or contest the claims made against you in following the advice of Jesus Christ and you have failed to respond.

We, in following with grace, are allowing you an additional five (5) days from receipt of this notice to respond to this action or be in an ecclesiastical Notarial default as applies to you on your private side. As indicated previously, and in honor I expect the honor in return and require that any and all responses must be under oath or attestation in the form of a **notarized asseveration**, upon full acceptance of private liability and penalty for perjury, and forwarded to Paul-Joseph: of the Ricci family C/o: of Kia West Edmonton, 10151 – 179 Street, Edmonton, Alberta, *no code non commercial*.

Failure to respond and honor the *ecclesiastical "Diligent notice of lawful excuse"* of **Paul-Joseph: of the Ricci family**, dated July 30, 2008 will be deemed to mean you have evidently waived your right to a Notice of Protest and consent to, do admit to, and confess to an immediate ecclesiastical default judgment as herein decided and agreed upon and witnessed in the universal court of conscience.

In absence of such response in denying liability and offering proof of error in our agreement, an ecclesiastical **default judgment** is gracefully and honorably accepted as of your lack of defense contrary to the evidence/facts which indicates your submission to private liability for damages and reasonable costs incurred since the inception of the unlawful claims and intimidation began via unlawful application of law.

The amount of nine hundred and forty-eight thousand dollars (\$948,000.00 dollars), based on the following amounts: Damages of approximately one hundred and ninety thousand dollars (\$190,000.00) for unlawful seizure of funds, \$300,000.00 dollars in damages for unlawful application of law causing shock and duress as of loss of security, freedom and right to gain a livelihood, \$300,000.00 dollars for defrauding me of my families security and livelihood for approximately five years and adding 20% (1/5th) of \$158,000.00 in accordance within the Bible in *Leviticus 6:2-5*.


